

# Privacy Policy Twin Locust Barns, Inc.

# **Introduction**

Twin Locust Barns, Inc. ("We") respect your privacy and are committed to protecting it through our compliance with this privacy policy. This privacy policy (together with our terms of use at www.twinlocustbarnsinc.com and any other documents referred to in it or relating to Twin Locust Barns, Inc.) describes the personal information that we collect from you, or that you provided on this website <u>www.twinlocustbarnsinc.com</u> ("Website") and how that information may be used or disclosed by us.

Please read our privacy policy terms carefully before using this Website to understand our policies and practices regarding your personal information and how we will treat it. By using our Website, you agree to the terms set forth in this policy. This Privacy Policy is not a contract and does not create any legal rights or obligations. Rather, the following are guidelines for protecting the information you provide to us. Please refrain from using our Website if you disagree with anything stated below.

# **Personal Information**

We collect several types of personal information from and about users of our Website, including information you provide to us either through our Website or call center. Your use of this Website constitutes your consent to collect and use your personal information obtained from you. For purposes of this policy only, "personal information" refers to any information by which you can be personally identified that includes name, e-mail address, mailing address, telephone number, credit card information, your responses to our survey questions, and information relating to any orders you place.

# Non-Personally Identifiable Information

Our Website also collects technical and navigational information that is not personally identifiable to any particular user. This type of information may include computer browser type, internet protocol (IP) address, pages visited, and time spent on our Website, and other communication data. This information may be used or analyzed by us to improve our web design and functionality, enhance our ability to service you, and estimate our audience size and usage patterns. For the same reasons, we may also obtain other non-personally identifiable information about your general internet usage by using cookies. You may refuse to accept cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. We may share non-personally identifiable information with third parties in connection with referral relationships and for reasons stated above.

# **Providing Online Support**

We may provide online customer service chat sessions to assist you while you are navigating through our Website. We will use and maintain any personal information you provide via these sessions in accordance with this privacy policy. We and our 3rd party service provider of the online customer chat feature may maintain dialogue transcripts of the online chats with us for staff training, for quality assurance purposes, or for other purposes as described herein.

# **Minors**

We do not knowingly collect personal information from minors and ask that children under 18 years of age not submit personal information on our Website without parental consent. Although we cannot prevent children under 18 from submitting personal information, we will destroy such information if we are made aware that proper consent was not given.

# **Use/Disclosure**

We use information that we collect about you or that you provide to us, including any personal information, in the following ways: responding to your inquiries, providing you with information about our products and services that you request from us or other information that you find useful (regardless if a business relationship exists between us), aggregate statistics about our customer's preferences, processing orders you have submitted, maintaining your account, to carry out obligations and enforce our rights arising from any contracts entered into between you and us. To ensure that you receive any e-mails that we may send to you, confirmations may be sent to us or our service provider when you open such emails or click certain email links. These confirmations may also show whether your e-mail application supports graphics, so we can tailor our messages to you.

Occasionally, we may deliver marketing and account information relevant to you, such as promotional offers, information about new product offerings, reservation confirmations, surveys, account information, notification services, and for administrative reasons.

We do **not** sell or release your personal information to outside organizations. Third party service and product suppliers, however, may be engaged by Twin Locust Barns, Inc. to perform a variety of functions, such as fulfilling orders, assisting with promotions, credit card processing, transportation services, conducting contests or services, providing technical services for our Website, etc. We may at times share information about you that is necessary for the outside company to provide the requested service. These outside companies may only use such information about you for the limited purpose of performing their services and may not use such information for any other purpose.

We reserve the right to disclose your personally identifiable information as required by law if we believe that disclosure is necessary to protect our rights, for fraud detection or prevention, and/or to comply with a judicial proceeding, court order, or other legal processes (e.g., subpoenas).

We permit and encourage you to request that any inaccuracies in your personal information be corrected or that such personal information be removed from our marketing databases.

#### **Security**
